English Oak (T1) - Crown raise include 5 secondary branches, deadwood - decrease shading reduce leverage.

Sycamore (T2) - Crown raise 6m Remove low branches over house.

Holly (T3) - 50% Reduction. Good Tree management.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
