T1 - BLACK ALDER For this tree at the property, our intention is to clean the crown and lift it to 5metres in order to curate the aesthetic of the Alder and ensure less resistance to the passing of poor weather while also creating an avenue for further light to flow. Our belief is that our arboricutural efforts will improve the overall condition and amenity value of the tree.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
