With regards to point 1 – windows. Only slim-line units (4/4/4 or 4/6/6 – dependent) with true (through) glazing bars will be acceptable. False (stuck on) glazing bars, or standard (24/28mm) DG units will not be accepted. This is standard practice for new additions to historic buildings. The dimensions of the proposed glazing bars will need to best match the extant.
