T5 Beech tree - Approximately 3 metres into the garden of 53 Lilliput Road from the rear boundary fence with the school and 1 metre into the site from the side boundary fence. A tree surgeon has advised the tree is dead and has advised it urgently needs to be removed. The tree is next to a public footpath F.P.No.117 Anthonys Avenue and F.P.57. This path is used daily by parents and their children who attend Lilliput School as well as the general public. It is also next to the school car park where teachers and parents park their vehicles and next to the vicarage of the church and presents a harzard to the vicarage as well as our property of 53 Lilliput Road.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
