Rear Garden

T1 - Mimosa Tree - Reduce by 2m overall, Tree leans at 45 degress, take weight off to stop it leaning further.

- T2 Hawthorn Tree Neighbours Tree, cut back to boundary line approx. 2m off, branches overhang flower bed.
- T3 Eucalyptus Tree Re-pollard to previous cutting points, approx. 3-4m off, to control size of tree.
- T4 Blackthorn Tree Reduce by approx. 2-2.5m overall, to control size of tree.
- T5 Acacia Tree Reduce by 35% overall, to control size of the Tree.
- T6 Prunus Tree Fell to ground level, Tree is 95% dead.
- T7 Eucalyptus Tree Re-pollard to previous cutting points approx. 3-4m off, control size of the Tree.

T8 - Mimosa Tree - Reduce by approx. 2-2.5m overall, to control size of Tree for location near Neighbours House. Front Garden

T9 - Silver Birch - Reduce by 30% overall to tidy and contain.
