Details of the pre-application advice received

I have passed it on to colleagues who have looked into the detail of the application and they have concluded that planning permission is required for the following reasons:

This type of structure on private land does not fall under Permitted Development.

• We have looked into similar situations, such as the replacement of bird hides on the Cley bird reserve and planning permission was sought in these instances.

• There appears to be no planning consent for the original bird hide (The only permission is PF/97/1077 which relates to a disabled access hide which is located further to the east)
