Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The property is not a Listed Building and it is not in a Conservation Area or World Heritage Site. The solar equipment is being sited to minimise the effect on the external appearance of the building and the amenity of the area, with the proposed solar panels to be sited on the rear South-facing roof, which is not visible from the public highway, and the proposed battery to be sited inside the attached garage. The panels will not be installed above the highest part of the roof (there is no chimney) and will not project more than 200mm from the roof slope. The cabling to the storage battery will be sited for minimal visual impact and the battery itself will be sited inside the attached garage.
