Thank you for your recent Tree application which has now been validated and allocated to one of our Tree Officers.

If the subject trees are not clearly visible and readily accessible, the Tree Officer may contact the tree owner to arrange access to the trees. For your information the application is now in a public consultation period of approximately 4 weeks, after which time the Officer is able to progress with their determination. Every effort is made to issue the decision before the expiry date of 29th December 2023 however the Tree Service often experience a very high volume of enquiries and this can result in unavoidable delays.

Every effort will be made to issue a decision by the "Target date" given above. However, we are currently experiencing a high volume of applications which may lead to your application not being decided within this time frame.

If you have not received a decision by the expiry date, you may appeal to the Planning Inspectorate for non determination. For more details, please visit their web site <https://www.gov.uk/government/organisations/planning-inspectorate>

Please note that non determination does not mean you are entitled to carry out unauthorised works and it is a legal requirement to obtain consent from the Council (or the Planning Inspectorate) regardless of whether the determination is made before or after the

8 week period. This is a change to the previous legislation and took effect in 2012.

Any unauthorised works to protected trees may be brought to the attention of the Planning Enforcement team for investigation and this could lead to prosecution.
