I have 2 Ash trees at the rear of the property to the left hand side, which are getting out of control, encroaching into next doors garden, blocking a lot of light into our garden and leaving a lot of debris and leaves over both our garden and the neighbours. The biggest tree out of the two is completely engulfed in Ivy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
