We have 2 magnolia trees in our garden. They are not under a preservation order but we live in a conservation area. They were topped to reduce height and width in 2019 after an application was made and permission was granted. (August 2019). They have now regrown with lots of upward pointing shoots and need crowning and reshaping as the leaves now reach across the width of the garden again. They now are out of proportion with the garden and house, and twigs and leaves are growing over the shed. We would like to do this and have an arborealist who has agreed to do the work.

Please inform us if we need to reapply every three to four years to remove the upward shooting growths or in future can we proceed as needed?

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
