T1 Silver Birch - Rear garden LHB: Crown Reduction - To reduce the overall height and spread by up to 1.5 metre/s and thin the overall canopy by up to 10% to create a more even crown density.

T2 Loquat - Neighbouring tree (at 84) RHB: Crown reduction - To reduce the overall height by up to 1 metre and shape into a more rounded shape. To include thinning the overall canopy by up to 10%.

Reason for work: General maintenance
