Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Common Lime - Crown Reduction - To reduce the height and radial spread of the canopy by up to 2 metres and to shape accordingly. Crown lift: To raise the lower canopy to create a 3 metres over the footpath and 5.5 metres over the road. To remove major deadwood and basal growth. Large tree dbh (450-700mm) with dieback in areas of the canopy. T2 Norway Maple 'Crimson King' - Crown Reduction - To reduce the overall height and radial spread cutting back away from building to provide approximately 2 metres clearance. Large tree dbh (450-700mm). T3 Horse Chestnut – Crown Reduction - To reduce the overall height and radial spread cutting back away from street sign to provide a 1-2 metre/s clearance. Large tree dbh (450-700mm). T4 - T8 Horse Chestnut - Crown Reduction - To reduce the overall height and radial spread of the canopy by up to 2-3 metres. Large tree dbh (450-700mm) which is overgrowing its location. The area has overly dense planting of mature tree units for the location. T9 Horse Chestnut – Crown Reduction - To reduce the overall height and radial spread of the canopy by up to 2-3 metres. Large tree dbh (450-700mm) which is overgrowing its location and has numerous excessively end-weighted primary branches. The area has overly dense planting of mature tree units for the location. T10 Horse Chestnut - Crown Reduction - To reduce the overall height and radial spread of the canopy by up to 2 metres. Medium tree dbh (250-450mm) which is overgrowing its location. T12 Sycamore - Crown Reduction - To reduce the overall height and radial spread of the canopy by up to 2-3 metres cutting back off both buildings to provide approximately 2 metres clearance. Large tree dbh (450-700mm) which is overgrowing its location.

T14 Leyland Cypress - Hedge reduction: To reduce the height by up to 1 metre, shaping accordingly to create a tight and compact hedge. Small tree dbh (100-250mm) which has historically managed as a tight rectangular hedge and has now lapsed. Necrotic patches in the lower canopy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
