Face up on garden side ensuring to keep a good live screen.
T.1 - remove 3 lower rear lateral limbs encroaching in wall back to main stem. Face up left hand end to be square with end of box hedge.
T.3 - Golden leylandii - remove to ground level.

Tree work carried out to give more light to neighbouring house behind, due to level difference in ground.
