Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

G1, hedge of hawthorn, elm, sycamore and ash with ivy, 6m tall, average stem diameter 8cm. The hedge is out-grown and blocks the view of the park from Pinfold Lane, following requests from residents to restore the view of the park and consultation with the parish council and a hedge specialist, the proposal is to coppice the hedge to 30cm high to allow it to regrow and eventually be managed as a laid hedge. 6x sycamore trees (30cm x 15m) and 1x elm have been marked with orange spots to retain.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
