We propose to amend the approved plans for Unit 2's floor plan, roof plan and elevations. The proposed roof plan features the same number of rooflights as formerly approved. These are broadly in the same location and are of a similar size to the original approval. The proposed east elevation appears the same as the original approval. The proposed west and east elevations demonstrate reduced fenestration and more basic form than was previously supported. Similarly, the proposed north elevation seeks a reduced fenestration and a simpler design aesthetic. Internally, the proposed layout offers the same open area gym with ancillary areas to the east. The proposed layout includes a complimentary physiotherapy area when needed and an office for gym management.
