Beech T1 - Overall crown reduction up to a maximum of 3m, back to suitable growth points. Reason(s): Onset of some modest canopy dysfunction potentially due to Phytophthora kernoviae (Beech tree canker).

Beech T2 - Crown reduce down the primary ascending trunk(s) on the southern canopy extents, which overhang the garage of the neighbouring property (Comfort House) by up to 4m back to suitable growth points. Reason(s): Concerns that the trunk is of substantial weight and is becoming increasingly overbearing towards the property. Alleviate biomechanical stress and reduce potential risk of failure to an acceptable level.

Beech T3 - Overall crown reduction up to a maximum of 3m, back to suitable growth points. Reason(s): To contain the trees as a group and maintain crown coalescence and group symmetry.

All works to be carried out in accordance with BS3998:2010 Tree work - Recommendations
