The sycamore has died this year, and seemed to die suddenly.
It's a substantial tree, whose canopy and roots extend into several neighbouring gardens and also overhang a property in Grosvenor Mount, and the ginnel joining Grosvenor Road and Grosvenor Mount, a public thoroughfare. As it's now dead we're extremely concerned about its stability. The risk is damage to property and also potentially to human life as the ginnel is heavily used by pedestrians making their way between Headingley/Meanwood and the city centre.
