The building inspector agreed this was an acceptable compromise. We have also spoken to Mark Rochford of planning permission who said he can not see this being a problem. This section of the roof is not visible by anybody except us and will still be tiled on the front section as set out on the original plans. I can provide photos of the front of the garage as viewed by anyone else.
