Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

G1 - A group of small trees consisting of Laburnum and Cotoneaster on the eastern boundary in the front garden, situated in close proximity to the wall, house and windows. Causing excessive shading in the house, and could cause issue with the wall and foundations if left unmanaged.

- Requesting permission to pollard the Laburnum and Cotoneaster down to wall height (2m) to allow regeneration and to be maintained as a 'hedge'.

T2 - Magnolia growing in close proximity to the front of the house and the greenhouse. This tree has outgrown its location and is now hindering repair work required on the greenhouse.

- Requesting permission to fell and remove to ground level and replant another Magnolia elsewhere in the garden.

T3 - Lime tree growing in the front garden adjacent to the driveway. The phone line passes through the outer canopy to the west.

- Requesting permission to prune selected branches to provide 1m clearance from the phone line.

H4 - Yew hedge growing along the entire western boundary on the driveway. This hedge has been regularly trimmed but is now encroaching and overlapping the driveway by approximately 1m. As a consequence, it is now difficult to turn vehicles around, and pass through the narrowing gap between the hedge and the outbuilding.

- Requesting permission to reduce the width of the hedge on drive side only by 1m, to provide a straight edge and reduce encroachment onto the driveway. The owner will plant small Yews to fill the gaps where necessary, to be maintained as a green hedge in the future seasons.

T5 - Acacia in the north eastern corner of the rear garden. Low branching has become a hinderance and is now difficult to walk and mow the grass underneath the canopy.

- Requesting permission to remove lower branches up to a height of 3m to reduce encroachment.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
