Yew (Taxus Baccata)
Crown Reduction and Thinning, as shown on photograph included.

This is a tree which has grown substantially within the last three decades. It is positioned close to the wall of the neighbour's barn and leans steeply away from it, towards the Old Malt House which it is near. In its distant history, a limb of some 30 centimetres diameter was cut off off, some 95 Centimetres above ground, with some rot in what remains of it. The work will offset problems that could arise in the future, and it will match its surroundings better in scale, and will lessen the chance of causing damage to the Old Malt House.
