As the original yellow London stock bricks could be severely damaged, a second option would be considered, so the "plan B" could be to have a render finish in baby pink colour. Rear facade will be restored to properly reinstate the original yellow London stock bricks. Rear extension will be in standard blockwork, in limestone finish - natural cream colour.
