The tree in question TPO No LBE 328 is a Robinia Pseudoacacia (not the hornbeam listed on the TPO map) is causing damage to surrounding walls on both mine and my neighbours property. I have previously been forced to replace the retaing wall due to the damage caused. I wish to remove the tree and replace with a smaller British specimen more in keeping with the space.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
