Driveway damaged caused by root growth. The tarmac has been lifted and has started to crack and wash away from this damage.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

(T1) - Macrocarpa tree. Located in the Meighbour property. The aim is to expose the roots causing the damage back past the tarmac area and prune off. Removing the roots to then reinstate the driveway with appropriate sun base and tarmac. Approximate diameter of the roots are up to 50-60mm estimated. There are 6-7 areas that have damage, potentially two pairs may be from a single root and the longest length from driveway edge is 4.8m. (Distance from driveway edge to the tree approximately 2m).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
