Suggested Works: marked a on map - remove north westernmost stem on; marked b on map - remove first two lowest branches on western stem

Reduce all stems in group to previous pruning points, maximum diameter of cuts (MDC 25mm.

#### T2 - Birch

Suggested Works: Tip reduce height by approximately 1.5-2 metres, MDC 25mm.

Rationale: These works are suggested as part of the reasonable maintenance of these trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
