T1 - Date Palm 9m tall. Remove to ground level as its growing too close to the house.
T2 - Medium Ash tree. Historically been pollarded to 4m. Canopy currently at 8m high.  Section fell to ground level and poison stump.
T3 - Medium Weeping Willow tree approximately 8m tall and 10m in diameter. Tree is dominating garden. Section fell to ground level and grind stump.
T4 - Palm tree 4m tall. Tree is under weeping willow tree and does not look very attractive.

Section fell to ground level and grind stump.

T5 - Small Bird Willow tree at 4m tall. Remove and grind stump.
