The tree is a Silver Birch which is located outside of number 37 Cangle Junction. We have been asked to remove the tree on behalf of the Riverside Group due to several reasons. The roots of the tree are causing the footpath to become uneven and difficult for a wheelchair user to access the block. The roots are also near to a drainage system and there are worries that there is potential for the roots to damage the system. The tree is also within close proximity of the building. Once the tree has been removed, Riverside will then be able to relay the footpath. The site falls within Haverhill Queen Street Conservation Area. The tree stump will then be ground out once service drawings have been received and CAT scanning has taken place.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
