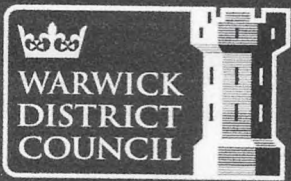

The tree was severely cut back 15/16+ years ago when it was damaging overhead services cables and being hit by lorries using the road. The tree is now losing its bark and several branches have now died. It was a lovely tree but in the wrong place. The tree is now an eyesore and needs to be taken out, and something more appropriate planted in the area.
