T1 - Robinia pseudoacacia - Crown reduce southwest side of tree by 2m to leave height of 12m and radial spread of 7m and tidy up storm damaged branch to leave flush cut. A branch around 5m in leant with a girth of 25cm has recently snapped out of the tree and the reduction

on the south west side it to reduce the risk of future failure of the branches over neighbouring property.

T2 - Populus alba - Pollard tree to height of 6m and radial spread of 3m due to large branch braking out into neighbours garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
