T1 Holly - reduce height of tree by 2.0 metres to rebalance crown following the removal of dense ivy accumulation. Trim sides to leave a balanced crown.

T2 Ash - remove tree to ground level and treat stump to prevent regrowth to remove likelihood hood of damage to properties boundary wall.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
