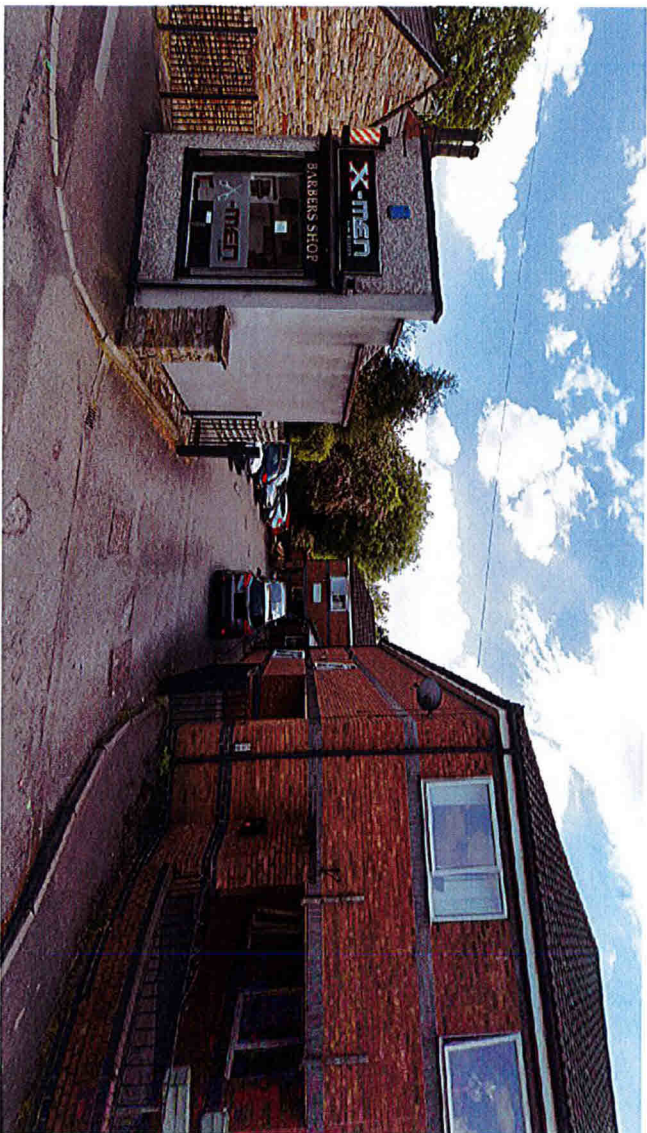
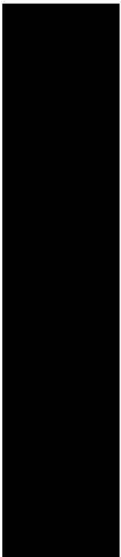

I will provide you with typed version of the proposed works, the hedge row to the east of the building is becoming quiet overgrow, with some large branches from the large situated ash tree touching the building.

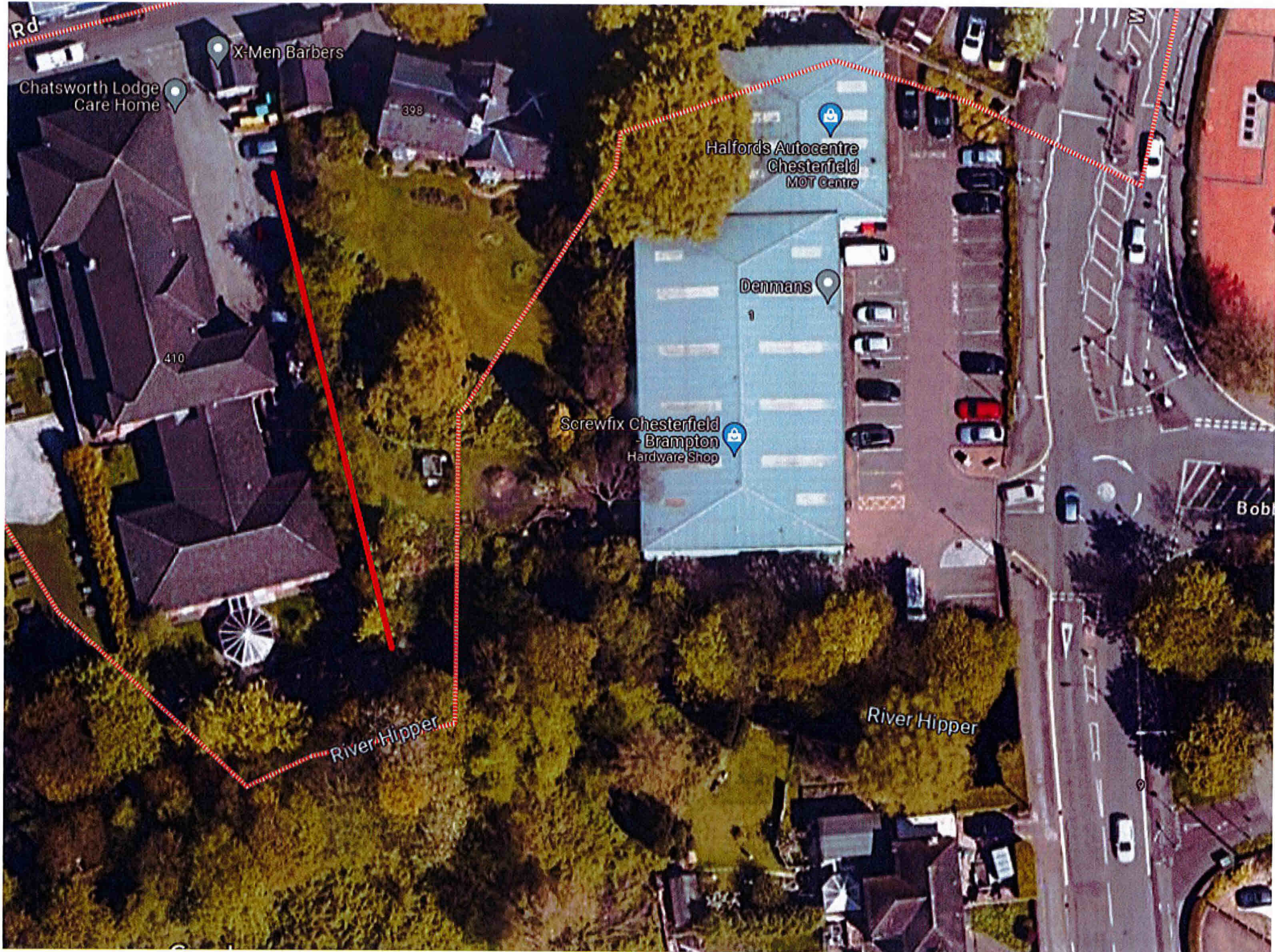
The care home would like the hedgerow cut back by 3m down the full east side of the building and also 3m from head height.
