## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The diseased tree is the only tree behind the garage of the Hallgarth House property (grid reference NZ 01139 19903). It is a mature horse chestnut which has lost a large limb from the upper part of the tree. The nearby branches to the lost limb appear to be weakened according to tree surgeon (Lee Jopling) and require removal for safety reasons (potential damage to my and neighbours buildings and property). Additionally, there is much disease round the base of the tree (horse chestnut canker according to tree surgeon). It spreads at least at least 30-40% round the base of the tree. The tree appears to be weakened and could be in danger of complete collapse. This could cause considerable damage to my and neighbours property and also block the the road. It may require the whole tree to be felled. If felled the tree would be replaced by a 3 year old oak tree which has already been grown using local seed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
