Chimney

Existing materials and finishes:

The chimney is of clay brick construction with 4 clay pots, 2 of which have been capped. The flaunching is of sharp sand and cement. The chimney stack is pointed with a lime mortar, of building sand and cement and hydrated lime mix. It has no flashing but relies on a clay tile creasing to seal between the brickwork and roof tiles.

Proposed materials and finishes:

Rebuild chimney stack with as many saved clay bricks as possible and make up shortfall with salvaged clay bricks to same design. Install a stepped lead dampcourse.
