We have three Maple trees at the side of our property. The two rear trees on the sketch are now interfering with the property & we have been advised by a tree surgeon these require a hard cut back. The front Maple only requires a soft cut back. The work has been scheduled in for Thursday 21st December 2023, pending no objections.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
