In accord with Condition 1 of the permission and as notified on 24/01/2019, enabling work to parking bays and entrance gates as drawing 588/P/14 was commenced on 30/01/2019 and completed by 29/03/2019. This work conforms to the approved site layout so it is considered that a material start has been made.  
 No work proposed or contracted at that time being above ground it was considered that it was premature to attempt to satisfy Condition 2.
