I refer to site visit by Clive Dawson 7.11.2023 concerning the deteriorating condition of the 4 remaining Mountain Ash trees designated as MA1,MA2, MA5 & MA8 on plan submitted on Application ref./TPO 15/1857. We discussed the rot occurring in the trunk of MA1 and the increasing amount of dead wood and evidence of further die back in all four trees. As discussed we formally request the removal of these four trees now. As agreed, when these have been removed we are happy to plant a suitable tree in the area between MA1 and MA2. We confirm that since the TPO was granted 8 trees, being a mixture of fruit and ornamental have been planted on the site.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

on the TPO the trees in question were referenced as G2- 8 Mountain Ash. There were in fact 9 Mountain Ash. Four of the eight trees have already be removed under permissions granted by yourselves in 2016, MA3, MA4, MA7, and MA 6 in 2020. A fifth tree MA9 not detailed on the TPO was also removed under the permission granted in 2016.

We are now seeking permission to remove MA1, MA2, MA5 and MA8 because of their deteriorating condition.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
