The purpose of the work is to trim the existing trees to reduce overshadowing and increase light in the rear garden and to trim the Pseudoacacia in the front garden. No trees will be removed.

Dedham Vale Tree Surgery has inspected the site and recommended in the rear garden:

- Reducing the height of the two poplars previously trimmed in 2019 to the previously cut level
- Reducing the Ash tree and the Leylandii to the same level.
- In the front, the Pseudoacacia will be reduced by about 1/3

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
