T1. Oak Tree. This tree has not been reduce in approximately 8/10 years. We had recent previous applications accepted.

However the client would like to do less works now.

We would like permission for a 4 M crown lift, and a 1.5 M reduction on neighbours side.

This would help reduce the risk of root damage to properties and risk of failure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
