2 Ash trees at the bottom of the garden of 85 Blanche Lane and 1 Ash tree at the bottom of the garden of 89 Blanche Lane, all 3 trees are in the church yard but grow very close to the boundary of both houses, the trees are appox 60ft in height and the church are requesting all three trees be reduced in height by approx 10 feet due to the neighbours concerns they are growing too big and overhanging their gardens. All cuts

would be made to suitable growth points
