'Extension to barn, new cart lodge, conversion of stables and demolition of steel framed barn'

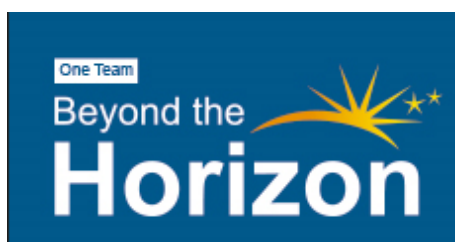
