This application is for work on the tall Ash tree growing against the wall in the rear garden of BayTree House. The tree appears to be dying back. The work would reduce the crown of the Ash to the level of the wall alongside it.
Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
The work is to reduce the crown of a very tall Ash tree growing against the wall in the rear garden of BayTree House.
Currently the tree is leaning over the yard and could potentially be dangerous and/or cause damage to the surrounding properties.
The crown would be reduced to the height of the wall it grows alongside.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
