TWO STOREY REAR EXTENSION TO PROVIDE ADDITIONAL LIVING FACILITIES

THE PROPERTY ALREADY HAS A SINGLE STOREY REAR EXTENSION RUNNING HALF THE WIDTH AND THIS PROPOSAL IS TO BUILD ABOVE THIS ELEMENT AND THEN BUILD AN ADJACENT TWO STOREY EXTENSION WHICH WILL BE AT A GREATER DEPTH - THUS CREATING AN L SHAPED STRUCTURE. THE PROPORTIONS ARE TO MATCH THE EXISTING REAR EXTENSION OF NO.8 THE LEYS. ALTHOUGH THE GROUND FLOOR WILL NOT HARM THE 45 DEGREE RULE WITH NEIGHBOURING NO.9, THERE WILL BE A SLIGHT COMPROMISE AT FIRST FLOOR LEVEL WHICH WE HAVE ILLUSTRATED ON THE PLANS PROVIDED WITH THIS APPLICATION. IT SHOULD BE NOTED THAT THE EXTENSION OF NO.8 ALREADY BREACHES THE 45 DEGREE RULE AND SO THERE IS PRECEDENT TWO DOORS DOWN. ADDITIONALLY NO.9 IS A LOCAL AUTHORITY PROPERTY AND NOT IN PRIVATE OWNERSHIP. THE EXTENSION WILL BE FINISHED IN RENDER WALLS TO MATCH THE EXISTING SIDE ELEVATION AND THE FINISH OF NEIGHBOURING REAR EXTENSIONS. THE COMPLETED STRUCTURE WILL BE TOPPED WITH A HIPPED ROOF TO NOT ONLY MATCH EXISTING BUT ALSO TO REDUCE VISUAL IMPACT.
