T1 Cedar: multiple recent branch failures and over-zealous pruning has significantly lowered the amenity value of the tree. It is proposed the tree will be felling to ground level and replacement planting to take place.

T2 Prunus: reduction of eastern aspect of the tree by 1.5-2m (current radial spread 6-6.5m) in order facilitate conflict free access to the driveway for taller vehicles.
