I want to fell this very large poplar tree (T1)since it is far too big and in danger of falling over in high winds. neighbours have also complained that it shades their houses and gardens. the roots are causing damage to pavements, walls, garage floors and gardens.

I plan to replace this tree with a smaller tree suitable for a garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
