Please describe the proposed advertisement(s)

We are applying on behalf of a newly formed Church called Re Church which was formed by the merging of 2 Churches, Renaissance Church (formerly based at Hillview Road, Carlton – the former premises of Foxhill Evangelical Church) and Carlton Community Church (based at Lowater Street, Carlton).

The 2 Churches merged earlier this year in January to form a larger congregation of over 100 people including adults and children, engaged in work in the Carlton community area.

As part of the merger and formation of the new Church, we are looking to put up the new name of the Church (Re Church) on the side of the building. Details are as follows:

3D Built up at faced letters/logo

Texts read 'Re CHURCH'

Powder coated to a std RAL colour

956mm high (On the R)

All letters 50mm deep.

Fitted with rear opal diffuser backtrays and internally illuminated with bright white LEDs for halo effect illumination.

The sign and illumination are to be designed for visual amenity. The sign will be in modern anthracite grey (dark) and the illumination will be daylight and night time sensitive, only being illuminated at night. As described above, the light will only light up around the letters of the name so as to produce a halo, dimmed effect and not a bright open light.
