T1 - Ash Tree

To reduce the weight and overhang by up to 4/5m back to suitable points.

Decay in main stem, previously damaged some years ago. Leans towards the house and garden.

T2 - Crack Willow Tree

To coppice to 2/3m to make safe.

Tree is pulling up it's roots and is leaning heavily, it will fail very soon, it is a huge tree and over mature. There is a large split running 2m up from it's root system, if it were to fail it will damage the car store and numerous other trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
