We need to remove our cherry tree. We have had advice from two different arborists that the tree has to be removed due to structural damage being caused to our home and garden walls. The roots of the tree are destabilising the garden walls and moving towards the house. One of the fences that is currently destabilised also backs on to a carpark, so if the tree was to bring down the wall, multiple cars could be damaged.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
