0170 - Western Red Cedar - Crown lift to 0.5m over the wall. Clear cross by 1.0m.
0171 Conifer group - Crown lift to 0.5m over the wall.
0175 & 0176 - Beech x2 - Crown clean by removing crossed branches up to 40mm in diameter and remove major deadwood throughout whole crown area (Deadwood > 30mm in diameter)
