Looking for an emergency notice for 2 Ash trees with die back 30-50ft tall. One of which is over a garage, the other next to Stroud Rd itself. They are also over power lines. Application for complete dismantle and removal to ground level. Tree contractors to arrange dropping of power lines.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
