(6) Within six months of works hereby approved commencing, a lighting design plan for biodiversity shall be submitted to, and approved in writing by, the Local Planning Authority. The plan shall show the type and locations of external lighting, demonstrating that areas to be lit will not disturb bat roosts. The plan shall also include measures to limit the spill from internal lighting. All external lighting will be installed in accordance with the specifications and locations set out in the plan and will be maintained thereafter. No additional lighting will be erected without consent.

REASON: In the interests of nature conservation in accordance with policy LB9 of the Canterbury District Local Plan 2017 and the National Planning Policy Framework.
