All trees require maintenance. Dead wood removal on the pine. The Acacia's have snapped out several times. Often single limbs but I request a pollard on Acacia 1 and a reduction for Acacia 2 to 5 meters.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
